As per the Rules and Regulations communicated by the Government, Board of Governors were constituted for APSWREIS. Further, in the reference  $3^{rd}$  read above, the Hon'ble Minister for SW was nominated as Chairman and the Prl.Secy., SCDD was appointed as Vice-Chairman to the A.P. Social Welfare Residential Educational Institutions Society.

read above, In the reference 4<sup>th</sup> 2. after bifurcation of AP State, Government has permitted for division of APSWREI Society into two Societies ie., TSWREIS and APSWREIS and consequently both the Societies have been registered as new Societies under Societies registration Act of 2001. Accordingly, the TSWREI Society has come into existence w.e.f. 2.6.2014 i.e., the date of appointed day.
